In pursuance of notification No. 34 dated 01/05/2021 of Hon'ble Gauhati High Court, it is hereby directed that;

- 1) There shall be restricted Court functioning with 'Staggered Roster' and only the matters as mentioned in the notification shall be taken up, exclusively, through virtual mode by all the courts.
- 2) The e-mail IDs, i.e. urgentcriminal.djk@gmail.com and urgentcivil.djk@gmail.com, as been created earlier as per order no. 76 dated 20/05/2020 of this office will be in operation, until further orders, for filing of fresh matters, involving urgency, if any.

The following staffs of this establishment, of filing section, are nominated as nodal persons, for submission of pen drive, if any, only if the soft copy of the relevant urgent matter is not filed/submitted through the aforesaid dedicated e-mail ID.

- 3) The old computer room in this establishment, as was identified and operational during earlier virtual hearings, shall be available for the advocates having inadequate facility for hearings through remote VC.
- 4) The advocates and litigants (where necessary), whose cases are listed on a particular date, only shall be allowed entry into the court premises.
- 5) The direction in the aforesaid notification regarding closure of bar rooms, (which is being duly discussed by the undersigned with the concerned President/Secretary of both the bars of this District Judiciary) shall be followed strictly.
- 6) All concerned shall strictly comply with the directions in the notification regarding their presence in the station and leaving the station.
- 7) The register being maintained in the entry point shall mention all the relevant particulars without fail. None shall be allowed entry without disclosure of the relevant particulars in the said register.


