





The Members present discussed various phases pertaining to speedy investigation and trial of the pending cases and resolved that:-

1. The meeting resolved that one small unit of Forensic Science Laboratory with one FSL expert should be arranged in Karimganj Civil Hospital for expeditious submission of FSL report. The meeting requested the Deputy Commissioner, Karimganj, to do the needful in this regard.
- 2) Superintendent of Police, Karimganj informed that 157 numbers of Injury Report and 31 numbers of Post Mortem Reports are yet to be received from the M.Os. The Joint Director of Health Services, Karimganj, are apprised to expedite the submission of report.
3. Service of summons and Warrant of Arrest in Criminal Cases are to be responded promptly. The Superintendent of Police, Karimganj, is apprised to take appropriate step in this matter.
4. Video Conferencing facility as directed by the Hon'ble Gauhati High Court for arrangement of recording of evidence of M.Os and I.Os through Video Conferencing are to be made to overcome the obstacles of the immediate disposal of the Criminal and Sessions cases. The meeting resolved to take necessary step in implementation of the direction / notification issued by the Hon'ble Gauhati High Court in this connection.
