IN PURSUANCE OF THE HON'BLE GAUHATI HIGH COURT'S NOTIFICATION NO. 52 DATED 20th AUGUST 2013, IN REFERENCE TO THE DIRECTION CONTAINED IN THE ORDER DATED 05.08,2013 AND 10.01.2014 PASSED IN WP© (TAKEN UP) NO. 4299 OF 2006 AND A.B. NO. 5537 OF 2013 RESPECTIVELY FOR THE MONTHS OF JANUARY, 2017, ATTENDED BY THE DISTRICT & SESSIONS JUDGE, DISTRICT MAGISTRATE, SUPERINTENDENT OF POLICE & JOINT DIRECTOR OF HEALTH SERVICES, KARIMGANJ.

Minutes of the monthly meeting held with the representative of the Deputy Commissioner, Karimganj, the Superintendent of Police, Karimganj and the Joint Director, Health, Karimganj on 11.01.2017 –

- (1) Matter of appointment of special public prosecutor or specification of the current public prosecutor as special public prosecutor under scheduled caste and scheduled tribe (Prevention of Atrocities Act) was raised by the District Judge in view of the fact of pendency of two cases under the said Act in the Court of Sessions, Karimganj and inability of the Court to proceed with the trial in absence of the special public prosecutor as objection has been raised by the defence against conduct of trial by the public prosecutor appointed under the Code of Criminal Procedure, 1973. The matter has been brought to the notice of Sri Santi Kumar Singh, D.D.C., Karimganj who represented the Deputy Commissioner, Karimganj and he has assured of initiating urgent appropriate steps in this regard.
- (2) In view of failure of the Investigating Officers in submitting inquest reports along with the charge sheet, in many cases of homicide, which has been brought to the notice of the Superintendent of Police by the District & Sessions Judge, Karimganj, the Superintendent of Police, Karimganj Sri P. R. Kar has assured of taking immediate steps in this regard.
- (3) The Superintendent of Police has pointed out that late issue of post mortem report and injury report by the hospitals is one of the major causes of delay in filing of charge sheets in criminal cases and, responding to the same, Dr. Mrs. Krishna Kamproh has assured to look into the matter and has suggested that Superintendent of Karimganj Civil Hospital may also be invited as a guest

member in the next meeting so that the matter can be sorted out in smoother way.

(4) The Superintendent of Police, Karimganj has also requested to ensure appointment of Motor Vehicle Inspector in Karimganj as absence of such appointment is a major cause of delay in investigation into accident cases.

(5) On suggestion made by the District Judge, Karimganj, the Superintendent of Police, Karimganj has assured of ensuring mentioning of phone numbers of the witnesses in charge sheet in criminal cases.
